Annual transfers-2015

04. A specimen of the Application for appeal is attached herewith. Kindly note to send applications prepared in accordance with the specimen before 28.10.2014 to be considered such appeals. The officers should be informed that the appeals received after that date will not be considered. Further it should be noted that the appeals, in which the employee number mentioned against the officer or number of NIC is not included, will not also be considered.

05. You are requested to release officers, who have been transferred outside your Ministry/Department/Provincial Council, without retaining them until their successors report for duty and enabling them to assume duties at new service station.
