02. Notification on calling applications and the specimen application are sent herewith and kindly inform the officers to properly perfect the applications and send them along with your recommendation by registered post or hand over to the Engineering Services Division of the Ministry Public Administration, Home Affairs, Provincial Councils and Local Government before 16.02.2024.

03. An advance copy of the properly perfected application should be sent also to the email esbpubad@gmail.com. Further, the officers who have not yet submitted their postgraduate degree/ postgraduate diploma certificates for verification as per my letter No. MPA/ESD/14/01/07/2023, dated 04.12.2023, should submit the certified copies of their postgraduate degree/ postgraduate diploma certificates to the Engineering Service Division of this Ministry without delay for verification.

04. The officers, who are unable to submit their applications in accordance with the relevant format before 16.02.2024, shall not be considered for promotion to Special Grade.

Promotion of Officers in Grade I of Sri Lanka Engineering Service to Special Grade

As per the provisions of the 6th amendment No: 2190/26 dated 25.08.2020, 7th amendment No: 2233/27 dated 23.06.2021 and the 8th amendment No: 2303/04 dated 25.10.2022 made to the Service Minute of Sri Lanka Engineering Service published in the Gazette Extra Ordinary No: 1836/6 dated 11.11.2013, applications are called from the eligible officers to fill the following vacancies in the approved cadre of Special Grade as at 01.07.2023.

Public Service Commission shall have the power to keep one or more of following posts unfilled.

02. Qualifications to be satisfied for Promotion to Special Grade

I. Shall have completed an active and satisfactory service period of five (05) years in Grade I of Sri Lanka Engineering Service and earned five (05) salary increments after getting promoted to Grade I.

II. Shall have completed an active service period of not less than 18 years in Sri Lanka Engineering Service as at the date of qualifying for the promotion.

III. Shall have proved an annual performance at satisfactory level or above in the five (05) years immediately preceding the date of qualifying for the promotion.

IV. Shall not have received disciplinary punishment as per the provisions stipulated in Public Service Commission Circular No: 1/2020.

V. (a) Shall have obtained the fellowship at the Institution of Engineers Sri Lanka (IESL) or any other equivalent fellowship from an engineering institute recognized by the Institution of Engineers Sri Lanka. It is compulsory to possess fellowship in the same field of engineering in which the chartered engineer status was obtained and being continuously maintained the fellowship.

or

(b) Shall have completed a Post Graduate Diploma/ Degree of which duration is not less than 09 months in the field of Engineering or shall have obtained Post Graduate Degree Certificate in Management or Business Administration and maintained the chartered engineer status continuously.

Note:

i. If the equivalent Fellowship has been obtained from an institution other than the Institution of Engineers Sri Lanka, a letter to certify that the said institution is recognized by the Institution of Engineers Sri Lanka should be submitted.

- ii. A certified copy of the certificate of fellowship should be submitted.
- iii. A letter to certify that the fellowship has been maintained continuously should be submitted.

03. Method of Promotion

- 3.1 Since promotion shall be made based on seniority as per the approval of the Public Service Commission in accordance with paragraphs 10.3.2 and 11.3 (d) as per the 8th revision made to the Service Minute published in the Gazette No. 2303/04 dated 25.10.2022, <u>an interview board appointed by the Public Service Commission</u> will make recommendations so as to give priority to the most senior officer, considering the order of preference for the posts applied for by the applicants, in order to promote the officers to Special Grade based on their seniority.
- 3.2 Number of applicants not more than twice the number of vacancies available as at 01.07.2022, who have satisfied the qualifications indicated in 10.3.1 shall be called for the said interview.
- 3.3 Officers shall be promoted to the posts, which have fallen vacant in Special Grade, based on the order of seniority list of Grade I of Sri Lanka Engineering Service and the seniority list of Special Grade as at 01.07.2022 shall be prepared in the order of seniority of the officers, who have become eligible to be promoted as at the said date, before they were promoted.
- 3.4 If the promotion cannot be made to a certain post as at 01.07.2022, action shall be taken considering the said post/ posts as a post, which has fallen vacant as at 01.01.2023.

04. Since all the vacancies shall be calculated as at 01st January and 01st July of each year, all the applicants shall have satisfied the qualifications indicated in Para. 02 above as at the date on which the vacancies mentioned in the notification on calling applications are calculated. Duly perfected applications prepared as per the specimen attached herewith shall be sent to me on or before **16.02.2024** through the Secretaries of Ministries, Chief Secretaries, District Secretaries, Heads of Departments. The late applications shall not be accepted and the incorrect and incomplete applications shall be rejected.

05. You are requested to inform the officers to apply only if they have satisfied the basic qualifications indicated above. The retired officers also can apply for the posts which have fallen vacant before the date of their retirement, if they have satisfied the qualifications mentioned under 03 above as at the date on which the posts have fallen vacant.

06. Action shall be taken as per the Public Service Commission Circular No: 01/2021 dated 30.06.2021, 01/2021(i) dated 02.08.2021 and 01/2022 dated 28.02.2022 against the officers who are unable to assume duty of the post to which he / she is appointed after promotion to Special Grade.

07. In case of any discrepancy between Sinhala, Tamil and English notifications the Sinhala notification shall prevail.
