- **7.2.2.4 Physical Fitness**: Should have adequate physical fitness and mental soundness to serve in any part of Sri Lanka as well as to properly undertake the role and responsibility of his post.
- **7.2.2.5** Other: Sub-section III will be removed.
  - **7.2.4 Method of Recruitment**: On the results of a written examination and a general interview.



Recruitments shall be made in consideration of the order or merit determined on the marks and the preference of the candidates who have passed the written examination and fulfilled the relevant qualifications. The number of candidates who are called for the inteview for recruitment to the post will be determined by the Public Service Commission.

Matters pertaining to the written competitive examination for recruitment under open stream are stated in Appendix 2.

7.2.4.4 General Interview: Scrutiny of qualification will only be carried out and marks will not be awarded.

#### Appendix 2

#### Written Competitive Examination for recruitment to Grade III of the Sri Lanka Architects Service under open stream

The Common Competitive Examination for filling up of vacancies in Grade III of the Executive Service Category is applicable to this exmination. The Commissioner General of Examinations will take action to conduct this examination annually.

#### 01. Scheme of Examination

Question Paper	Duration	Nature of the Question Paper	Pass Marks
Intelligence Test	1 1/2 Hours	100 marks, shall consist of multiple-choice questions and/or short answer type questions	40
Comprehension	02 Hours	100 marks, shall consist of multiple-choice questions and/or short answer type questions	40

#### 02. Syllabus

#### Intelligence Test

Shall consist of multiple-choice questions to test candidate's skills in reasoning, substitution, interpretation, relevance awareness, conversion, problem solving, understanding of cause & effect relationships, prediction, information organization, pattern identification and adherence to instructions.

#### Comprehension

Shall consist of objective type questions to test candidate's ability in comprehension and skills in communication, smmarization, analyzing and creativity.

#### 03. Medium of Examination

- I. This examination will be held in Sinhala, Tamil and English Languages.
- II. Candidates can sit for the examination in any one of these languages of their choice.
- III. Candidates should answer all question papers and select only one language for all the papers.
- IV. Candidates will not be allowed to change the medium of examination produced by them in the application form.
