Transfers to a Post in Development Officers' Service under the Combined Service, on the requests made by the Officers who have been appointed to Provincial Public Service under Provincial Development Officers Services as per the Public Service Commission Circulars No 04/2020

This is with Reference to the letter of the Secretary, Public Service Commission No PSC/EST/06-05/03/2015 dated 30.01.2020 and the Public Service Commission Circular 04/2020 on the above.

- 02. Accordingly, when an officer who has been appointed to a post in the Development Officers' Service in the Provincial Public Service, intends to transfer to a post in the Development Officers' Service under Combined Service, an application in line with the specimen format given in Annex I should be submitted to the Director General of Combined Services through Provincial Chief Secretary. Copies of the documents in Annex 2 which are certified by the Head of the Institution and prepared in relevant order should also be submitted along with the application.
- 03. An officer appointed to a post in Development Officers' Service in Provincial Public Service who intends to transfer to a post in Development Officers' Service under Combined Services, should agree with the following conditions and an affidavit valid in Sri Lanka (in line with Annex 3) declaring the same, should be submitted as serial No 22 of Annex 02.
 - (i) In the event the officer gets an appointment in the Development Officer service belonging to the Combined Service, he/she shall agree to work anywhere in the island in accordance with the provisions of Circular 04/2020 of the Public Service Commission
 - (ii) To place on the seniority after all the officers who are already in service in line with the seniority of the officers in the Development Officers' Service belonging to Combined Service corresponding to the Grades to which the officer is appointed in the Provincial Development Officers' Service.

- (iii) To give up grade promotions in the Provincial Public Service except a promotion which corresponds to the Grade Promotions in the Minute of Development Officers' Service in the Combined Services.
- (iv) If there is any discrepancy between the salary received in the Provincial Public Service and the salary corresponding to the grade to which the Development Officer is appointed under the Combined Service, he/she agrees to be placed on the salary received by a Parallel Officer in the Development Officer Service of the Combined Service.
- 04. If the officer is appointed to the post of Development Officer belonging to the Combined Service, the service station the officer intends to serve should be mentioned in the application form but no vacancy letter should be submitted. Also, no Head of Institution should make recommendations regarding the attachment of an officer in Provincial Public Service to a vacancy in the Development Officer service existing in his/her institution without the written notification of the Director General of Combined Services.
- 05. Director General of Combined Service ascertain whether vacancies are available in the service station in which the officers prefers to serve in Development Officers' Service under Combined Service, communicating with relevant Secretaries of Ministries or Heads of Departments and the Director General of Combined Service shall determine whether the officer to be appointed to the relevant post which is fallen vacant. Based on the said decision, the relevant Provincial Public Service Commission will take action regarding the release / non-release of the officer from the relevant Provincial Public Service.
- 06. In the event the Director General of Combined Services expresses his consent to appoint to a post in the Development Officers' Service under Combined Service, if the approval of the relevant Provincial Public Service Commission is granted to release the said officer from Provincial Development Officers' Service, the officer is absorbed into the Development Officers' Service under the Combined Service with effect from the date on which the officer assumes duties. The consent of the Director General of Combined Services to appoint the officer into a post in Development Officers' Service under Combined Service, shall be valid only for a period of one month.
- 07. The officer should immediately assume duties at the new service station once he or she is released from the Provincial Public Service Commission. Once the relevant Head of the Department reports the Director General of Combined Services of the assumption of duties by the relevant officer, the Director General of Combined Services will issue a letter of absorption.
