The interview for recruitment of suitable persons to fill the vacancies in the posts of Engineers, in Grade III of Sri Lanka Engineering Service at the island wide government institutions, is scheduled to be held on 10th December 2021 at the auditorium of Ministry of Public Services, Provincial Councils and Local Government, Independence Square, Colombo 07.

02. You are kindly informed to be present for this interview at on
with the originals of all documents mentioned below.

- I. Letter of calling for the interview.
- II. B.Sc Engineering degree certificate or a valid certificate obtained on completion of all educational and other requirements recognized by the University Grants Commission and Institute of Engineers Sri Lanka under a stream considered for recruitment as a qualification equivalent to that degree.
- III. Academic transcript of the degree based on which the above certificates were issued.
- IV. Result sheet of G.C.E. (O/L)
- V. Certificate of birth.

- VI. National Identity Card, Valid Passport or Valid Driving License.
- VII. **A set of photocopies** of the documents mentioned in II, III, IV, V, VI above **certified by yourself.**
- VIII. If you have obtained the BSc degree in Engineering or a qualification equivalent to the same as mentioned in Section 7.2.3.1 of the Minute of Sri Lanka Engineering Service published by the Gazette extraordinary No. 1836/6 dated 11.11.2013, from an institute, **which is not a state university in Sri Lanka,** a letter issued by the University Grants Commission of Sri Lanka certifying the course followed by you has been recognized by the said Commission.
- IX. A letter issued by the Institute of Engineers Sri Lanka to prove that the officer has obtained and continuously maintains the Associate Membership of the Institute of Engineers Sri Lanka **(to be valid for the year 2021)**
- X. Certificate issued by the Grama Niladhari in the Form D.S. 04 certifying your permanent residence and the character.
- XI. An affidavit attested by a Justice of Peace or Commissioner for Oaths for any difference in your name appeared in the birth certificate and educational or any other certificates or National Identity Card (Signature must be placed on a valid stamp of Rs.50)

03. If you are a Technical Officer in the Public Service or Provincial Public Service (Engineering Assistant, who belongs to Engineering Assistants' Service of the Department of Irrigation (Earlier Technical Assistant) or an officer holding a post of Supervising Manager of the Department of Railways or a Technical Officer, who is serving in the Public Service/ Provincial Public Service, possessing the qualifications approved by the appointing authority of Sri Lanka Technological Service), **it is compulsory to bring the originals of all the following documents and a set of photo copies certified by the Head of the Institution in addition to the documents mentioned above under I to XI of para 2.**

- I. Letter of appointment/ absorption to Engineering Assistants' Service of the Department Irrigation or Supervising Management Service of the Department of Railways or Sri Lanka Technological Service.
- II. Letter of confirmation in the service
- III. Letter issued by the Head of the Department certifying that the applicant has not been subjected to any disciplinary action during the immediately preceding five years and it is not intended to take any disciplinary action against the applicant in future. (It is compulsory to bring the original copy of the letter issued by the Head of the institution.)
- IV. Salary increment certificates and performance reports relevant to the immediately preceding five years (from 2016 to 2020). (It is sufficient to produce a set of photocopies certified by the Head of the institution.)

04. This interview will be held only to verify education qualifications of the candidates and other requirements, and no marks will be given.

05. The order of marks secured at the written test by the applicants, who have satisfied the basic qualifications, shall be followed when filling the expected number of vacancies and Public Service Commission shall reserve the right to make the final decision in this regard.

06. The effective date of appointments and number of recruitments shall be decided by the Public Service Commission. The Public Service Commission reserves the right to fill all or any number of the vacancies. At the instances, where there are candidates, who have secured equal marks, the appropriate decision in that regard shall be taken by the Public Service Commission and it shall be the final decision.

07. Travelling expenses or any allowance shall not be paid for this purpose.

08. Since the candidate who are unable to present at the time and the date allocated shall not be given another date you are kindly requested to prevent making such requests. Further it is compulsory to submit all the documents requested at the time of interview.

09. Further, it is **emphasized** that calling for this interview and appearing for the same shall not be the only qualification to be appointed to Grade III of Sri Lanka Engineering Service.
