Attaching visually impaired Development Officers belonging to Combined Services based on service exigency in the Provincial Public Service.

Regarding the attachment of visually impaired Development Officers belonging to Combined Services to the vacant posts that exist in the institutions under following provincial councils.

02. If visually impaired Development Officers belonging to Combined Services working attached to your Ministry/Department/ Office exercise their option to be attached to the vacant posts that exist in the institutions under provincial councils listed in the following table, there is a possibility of releasing them to a post in provincial public service as per the provisions of chapter XII of Procedural Rules of Public Service Commission published in the Gazette Extraordinary of the Democratic, Socialist Republic of Sri Lanka No. 2310/29 dated 14.12.2022.

Accordingly, if there are visually impaired Development Officers belonging to Combined Services working attached to your Ministry/Department/ Office who exercise their option to be attached to the following posts that remain vacant, you are kindly informed to prepare the documents required for releasing to provincial public service and send them to me with your recommendations.
