Calling for information on the inactive files of officers who received permanent appointments in the Development Officers' Service under the Combined Service

 - Particulars of the officers who have been treated as having vacated the post but have not yet submitted appeals(Annex 03)
 - Particulars of the officers who received appointments to the Development Officers' Service and passed away while engaged in the service (Annex 04)
