**Para No. : 8.1** The combined cadre for promotions within Grades : 2605  
For the purpose of promotion all Grades i. e. Grade I, Grade II and Grade III, shall be considered to be within the combined cadre.

**Para No. : 8.2** Number of approved post under each Grade :

**Para No. : 9** Posts belonging to the Service :  
Posts belonging to the Service are given in Appendix "A"  
Notwithstanding anything contrary to the SLAS Minute, posts already approved for the All Island Services and to be approved in future for the All Island Services would continue to be held by the respective services.

**Para 12.2 :** Second column, second row, the printing error should be corrected as "level"

**Para 13.3 (a)(vi) :** Having completed a period of at least three years (03) service in each of the following institutes during the period of service completed in the service :

- I In a post/posts in a Ministry or a Department or a Commission
- II In a post/posts in a Provincial Public Service
- III In a post/posts in a Divisional Secretariat or a Government Agent/District Secretariat

Note IV : The requirements stipulated in Para 13.3(a)(vi) above is applicable to all officers recruited to the service in year 2006 and after.

**First (I) Schedule Appendix "A" Schedule of posts in Special Grade**

No.1 "Secretary, Public Service Commission" and  
No. 51 "Additional Director General, Department of National Planning" should be removed.

**Second (II) Schedule 1.5 a.**

The First (I) and the Second (II) Efficiency Bar Examinations will be conducted until 31st December, 2014 as per the provisions stipulated in the Minute in force as at 01st January, 2005.
