MINUTE OF SRI LANKA ARCHITECTS' SERVICE

FOLLOWING amendments are made to the Minute of Sri Lanka Architects' Service published in the *Gazette Extraordinary* of the Democratic Socialist Republic of Sri Lanka No. 1877/28 dated 28.08.2014 as amended by the *Gazette Extraordinary* of the Democratic Socialist Republic of Sri Lanka No. 1882/18 dated 01.10.2014, No. 1952/20 dated 02.02.2016 and No. 1994/68 dated 24.11.2016, and the other matters and conditions thereof remain unchanged.

(1) 7.3.2.1. Educational/ Professional Qualifications and Experience

- I. Officers who have completed the qualifications in 7.2.2.1. who have completed an active and satisfactory period of service of 05 years in the Public or Provincial Public Service and who draw Salaries under the Salary code of MN 2 or above referred to in the Public Administration Circular 06/2006
- II. Officers who have passed the Standard Course - Part I at Sri Lanka Institute of Architects and who have completed 10 years of active and satisfactory service in the Public Service/ Provincial Public Service
And
- III. Draughtsman in Special Class of the Sri Lanka Technological Service with an immediately preceding 05 years of satisfactory period of Service

(2) 7.3.2.3. Other

- II. Should have completed a satisfactory period of Service during the immediately preceding 05 years
- IV. Should have confirmed in the Service.

(3) 10.2.1 Qualifications to be fulfilled

- I. Should have completed a five (05) years of active and satisfactory period of Service in Grade II of the category of Service and should have earned five (05) salary increments that fall due.



(4) 11.2 Method of Selection
